# What Information do we collect

# How will we store your data

All of the information you provide is kept within Farsound on our servers which are fully secured against any unauthorised access.

# Sharing and Disclosure of Information to 3rd Parties

Farsound respects your privacy and will never share the information collected via this website. All information provided will be kept secure, and will never be used in ways to which you never consented.

# Your rights

You have the following rights in relation to your personal data: -
